  - who, due to the apartheld policy that was in place, had no voting rights in the national elections prior to the introduction of the Constitution of the Republic of South Africa, 1983 (Act No. 100 of 1983) or the Constitution of 1) the Republic of South Africa, 1993 (Act No. 200 of 1993) ("the Interim Constitution"), and/or
    - 2) who is a woman, and/or
    - 3) who has a disability

With the understanding that any person who received South African oltizenship on or before the introduction of the interim Constitution, will not be deemed to be HDI.

- "A woman" refers to a female person who is a South African cilizen.
- "Disability" refers to a person with a permanent physical disability, mental disability, awareness disability, which leads to confinement or disability, or the inability to perform bodily functions in the manner or within the capacity of a normal person.

"How aguity ownership" refers to the percentage of a partnership or business that is owned by individuals, or in the case of a company, the percentage of shares which is owned by individuals who are actively involved in the management decisions and day to day operational activities of the company or business and who exercises control in the business in relation to their ownership at the close of tender. - 1 This Municipal Bidding Document (MBD) must form part of all bids Invited.
