Siyancuma Municipality hereby invites suitably prospective service providers to quote for "servicing of dosing pump and the replacement of 0.75KW 220V DAB Jetcom Pump" Sealed price quotations clearly marked "BID NO: ADVERTISEMENT: RFQ 07/2025/26 SERVICING OF DOSING PUMP AND THE REPLACEMENT OF 0.75 220V DAB JETCOM PUMP ON THE FARM OF VICKY BRUWER (OLIERIVIER)" clearly endorsed on the envelope must be submitted to Siyancuma Local Municipality, 13 Charl Cilliers street, DOUGLAS, 8730. - 1. Late, emailed, faxed, incomplete quotes will not be considered.
- 2. All quotes will be adjudicated and awarded in terms of the Siyancuma Local Municipality Procurement and Supply Chain Management Policy, the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and the regulations promulgated under this Act.
- 3. Bidders must be registered on the Central Supplier Data Base and must be compliant.

#### 5. Specifications:

- 1. Servicing of dosing pump
- 2. Replacement of 0.75KW 220V DAB Jetcom pump

The external pipework connecting the raw water source (dam) and the storage infrastructure (JoJo tanks) requires immediate replacement on the Vicky Bruwer farm (Olierivier). This necessity stems from significant degradation and material compromise observed due to prolonged exposure to adverse environmental and weather conditions. Continued use of the compromised pipework poses a risk to system integrity and water delivery efficiency.

#### **Required Scope of Work Summary**

The overall scope encompasses three critical areas to ensure the functional rehabilitation and operational readiness of the water system:

- System Maintenance and Servicing: Comprehensive maintenance is required for the entire water filtration system, including the crucial servicing, inspection, and calibration of all associated components, specifically the dosing pump(s), backwash pump(s), and primary filter pump(s).
- Complete replacement of the identified degraded external feed pipework is mandatory to restore resilience and reliability in water conveyance to the storage tanks.
- Site Preparation: Urgent cleaning and remediation of the immediate and surrounding areas of the dam and pump station must be executed prior to the commencement of any technical or installation works. This is essential to ensure a safe, accessible, and compliant working environment for all personnel.

Bidders **must** conduct a mandatory, non-chargeable site assessment prior to submitting a final quote.

NB: Failure to meet the above requirements or submission of documents, will lead to disqualification of the quotation

The following terms and conditions will apply.

With the understanding that any person who received South African citizenship on or before the introduction of the interim Constitution, will not be deemed to be HDI.

- "A woman" refers to a female person who is a South African citizen.
- "Disability" refers to a person with a permanent physical disability, mental disability, awareness disability, which leads to confinement or disability, or the inability to perform bodily functions in the manner or within the capacity of a normal person.
- "HDI equity ownership" refers to the percentage of a partnership or business that is owned by individuals, or in the case of a company, the percentage of shares which is owned by individuals who are actively involved in the management decisions and day to day operational activities of the company or business and who exercises control in the business in relation to their ownership at the close of tender. ### DECLARATION CERTIFICATE FOR LOCAL PRODUCTION AND CONTENT FOR DESIGNATED SECTORS

This Municipal Bidding Document (MBD) must form part of all bids invited. It contains general information and serves as a declaration form for local content (local production and local content are used interchangeably).

- 1.3. Where necessary, for bids referred to in paragraph 1.2 above, a two stage bidding process may be followed, where the first stage involves a minimum threshold for local production and content and the second stage price and B-BBEE.
- 1.4. A person awarded a contract in relation to a designated sector, may not sub-contract in such a manner that the local production and content of the overall value of the contract is reduced to below the stipulated minimum threshold.
- 1.5. The local content (LC) expressed as a percentage of the bid price must be calculated in accordance with the SABS approved technical specification number SATS 1286: 2011 as follows:

$$LC = [1 - x / y] *100$$

#### Where

- x is the imported content in Rand
- y is the bid price in Rand excluding value added tax (VAT)

Prices referred to in the determination of x must be converted to Rand (ZAR) by using the exchange rate published by the South African Reserve Bank (SARB) at 12:00 on the date of advertisement of the bid as required in paragraph 4.1 below.
